Blanket Radio Distributor License Agreement

Agreement made this ____ day of _____, 20____, by and between ZBS Radio Associates, "Licensor" and _____, American Longevity ID Number _____ "Licensee" for Licensee to receive use of specialized media tools developed and owned by Licensor for the purpose of building an American Longevity network marketing distributorship for the benefit of both Licensor and Licensee under the following terms and conditions:

- 1) Licensee is already or shall immediately become an American Longevity distributor with ZBS _____, ID # _____ as immediate upline sponsor and maintain a minimum ranking of Managing Associate on autoship with each of his or her minimum 3 Associate legs on autoship as well.
- 2) Licensee shall not vertically "stack" any additional positions between his or her own ZBS-licensed radio position and the principal sales volume from any radio station other than a maximum of one ZBS approved and licensed call center position and one ZBS approved and licensed radio station affiliate position so that principal sales volume shall appear not lower than the fourth level of the closest upline ZBS position.
- 3) Licensee shall qualify the position(s) of any radio station(s) sponsored by Licensee at the appropriate 100, 200, or 300 BV level to maximize station earnings each month that station broadcasts any ZBS media tools such as the long form radio program, short form medical reporter minutes, or half hour infomercials. In the event that any station receives less than the full commission amount it is due as a result of Licensee error, Licensee shall issue and send a check for the difference to arrive at the station by not later than the 25th of the applicable month.
- 4) Licensee shall be solely responsible for seeing to it that proper telephone numbers, web addresses, and ZBS-licensed and approved local retail outlet locations (by special advance written approval of ZBS) are inserted by the local affiliate stations into all local breaks, so that customers may be served and stations will get compensated as downlines are cultivated.
- 5) **Zero Tolerance Policy After 30 Days or Second Call:** ZBS will, for an absolute maximum period of thirty days following debut of long form program, refer any customer calls which come in from a new station's audience back to the appropriate call center for that station. After this thirty day period (or at ANY time the same customer calls back a second time seeking assistance) ZBS shall assign said customer to another distributor rather than further frustrate and run the risk of losing the customer.
- 6) Licensor reserves the right to modify the terms of this license and require Licensee to sign updated license agreement from time to time as deemed necessary by Licensor. In the event Licensee refuses to agree to the terms of any such new license agreement, Licensee's existing license shall be immediately revoked by Licensor and Licensee shall, from that time forward, be prohibited from acting as an agent for ZBS Radio products and signing any additional radio affiliates. This license is issued at the discretion of ZBS Radio Associates and may be revoked at any time by Licensor, with or without cause.
